Introduction

At present there is a large section of professionals in India with expertise to conduct Information Security Audits as independent auditors and also engaged with “CERT-In empanelled audit firms” . These auditors were expected to have multiple skills and knowledge of audit frameworks so that they demonstrate the capabilities to undertake Information System Controls audits from the perspective of compliance to the ITA 2000/2008 and DPDP Act 2023 provisions. This required a “Techno Legal Understanding” that not all IS auditors could manage successfully. As the DPDP Act, 2023 mandates the organisation to carry-out periodical ‘Data Audits’, the role of Techno Legal Auditors in India has undergone a further change and there is an imminent need to upgrade auditing skill to meet the legal and regulatory compliance of organisation in India in the coming days.

This transformation from Technical Information Security Audit to Techno Legal DPDPA audit is the need of the day and is being addressed by FDPPI through its C.DPO.DA. (Certified Data Protection Officer and Data Auditor) Course.

In order to provide the skill set to practicing and aspiring information security auditors, FDPPI is conducting a three-day in-person program exclusively designed for Information Security professionals and Auditors of CERT-In empanelled audit organizations.

The first of such program was held in Bengaluru, on 27th ,28th & 29th September 2024. The next program is scheduled in Mumbai from 24th to 26th January, 2025.
