





- A Non Exclusive mutual cooperation arrangement
 - DNV to use FDPPI-DNV DTS
 - FDPPI to provide Certification programs for DNV customers
 - FDPPI and DNV may conduct joint assignments related to training and audit





MEMBERSHIP

- FDPPI offers different types of memberships
 - Basic Membership
 - Eligible for all knowledge sharing services
 - Foundation Membership
 - Eligible for all knowledge sharing services and to vote as a member
 - Supporting Membership
