





Indian Data Protection Summit 2022: November 11,12 and 13

Indian Data Protection Summit (IDPS) is an annual flagship event of the Foundation of Data Protection Professionals in India (FDPPI).

FDPPI is a Not for Profit organization of Data Protection Professionals dedicated to the development of Data Protection Eco System in India and is engaged in conducting Certification programs for development of Data Privacy skills.

IDPS 2022 is being conducted as a Virtual Conference on November 11th, 12th and 13th of November 2022. The program runs from 2.00 pm IST to 8.00 pm IST on each of these three days to cater to the requirements of the global markets.

This year's program is being conducted in association with QRC Assurance and Solutions Pvt Ltd, Mumbai.

IDPS 2021 program consisted of 9 Panel discussions and 6 Keynote addresses from 52 eminent professionals from the industry. Over 1000 professionals registered for the event and on an average about 150 persons attended the live sessions. The details of IDPS 2021 are available at www.idps2021.in . The program schedule for IDPS 2022 is being finalized. The theme chosen is "Shape of Things to Come" to focus on the emerging data protection regulation in India with the proposed new Bill a draft of which could be available by the time the event is held. The first day of the event (11th November 2022) is reserved for discussing the law as proposed in the draft or as suggested by professionals and to provide awards for Privacy Champions recognized by FDPPI. We are therefore ready with content whether the Government is able to come up with a new draft bill in time or not.

November 12th and 13th is reserved for about 6 panel discussions and 3 keynote speeches. Speakers are being contacted now. There would be 5/6 international speakers, and other Indian speakers. There could be a total of around 30-40 speakers from the industry who could contribute to the thoughts.

After the event we intend producing a report a copy of which may be submitted to the Government.

We have finalized the top level sponsorship of the event which is being taken up by QRC Assurance and Services Pvt Ltd, Mumbai.

Platinum, Gold and Silver Sponsors would be provided with free minimum advertisement slots of 3, 2 and 1 respectively.

3. Attendance Boosting rewards

In order to boost the attendance for all sessions and continued presence during the sessions, we are considering providing some incentives in the form of PayTM vouchers to lucky participants . These could be sponsored by some vendors.

4. Awards for Privacy Champions

FDPPI would be providing Privacy awards to Individuals, Companies and Privacy Teams for their contribution to the Privacy and Data Protection eco system. The award function will be exclusively conducted on 11th and could be sponsored separately.
