- Foundation of Data Protection Professionals in India
- Registered on 17th September 2018
 - As a Section 8 company (Not for Profit)
 - Limited by Guarantee (Not by Shares)
- Initially funded by individual members through
 - “ Donation for Membership ”
- Now sustained through “Effort Donation” by supporting members
 - Generating revenue surplus through Certification programs and Services to the industry

UNIQUENESS OF PDPSI

- Contains
 - 12 Standards
 - 50 Model Implementation Specifications (MIS)
- Incorporates flexibility to create Risk specific Implementation Charter
 - based on a “Deviation Justification Document” and
 - adoption of modified implementation specifications referred to as “Adopted Implementation Specification”
- Uses the MIS based evaluation for DTS calculation
- Provides option for disclosure or non disclosure of DTS



FDPPI-DNV COLLABORATION



- A Non Exclusive mutual cooperation arrangement
 - DNV to use FDPPI-DNV DTS
 - FDPPI to provide Certification programs for DNV customers
 - FDPPI and DNV may conduct joint assignments related to training and audit





OUR RESOURCES

- Every one of our members is a resource for Pro Bono activities
- Supporting members (38) are resource for execution of projects
 - Each Supporting member is himself a small Audit or Training Company with its own set of professional employees.
 - FDPPI will undertake projects which will be executed by the Supporting Members
 - FDPPI capacity is therefore equivalent to 38 small/Micro firms.
 - Six of these firms have already entered into a contract to be “Certification Bodies” for PDPSI based audit and DTS evaluation
 - They are mandated to use at least one Certified PDP CMS Auditor as the project lead.
 - The audit reports are reviewed by FDPPI for quality purposes
