Prospectus

FDPPI (Foundation of Data Protection Professionals) is a pioneering institution in India which has initiated a structured program to develop professionals for the Data Protection Era that is coming up in India.

FDPPI is a Section 8 (Not for profit) Company limited by guarantees. Started in September 2018, FDPPI has already established a comprehensive Certification Program for Data Protection Professionals consisting of 5 modules each of which will be independent and collectively lead to a Certificate titled "Certified Expert Data Protection Professional" (CEDPP).

This is a unique concept where for the first time a Certification program will create awareness and skills in the knowledge and skills required by a Data Protection Professional.

The Five modules are as follows.

Module-I: Indian Data Protection Laws

Module-G: Global Data Protection Laws

Module T: Technology Essentials for Data Protection Professionals

Module A: Audit Skills for Data Protection Professionals

Module B: Behavioural Skills for Data Protection Professionals

Currently two batches of Module I have already been completed and one of the last programs in the current series is being planned as week end online program on 6th, 7th, 13th and 14th June consisting of two sessions of 90 minutes each on each of the four days, totaling upto 12 hours.

In the month of July Module-G is scheduled to be launched. Other modules will be introduced in due course.

The Course is presently designed on the basis of the Personal Data Protection Bill 2019. All the participants of the program would be provided a free online "Bridging Session" when the Bill is finally passed into law to appraise of the changes if any between the current version and what would come up finally in the Act when passed.

Appropriate Course material will be made available.

After the training there would be an online examination based on which the Certification would be provided by FDPPI.

Who should take this Course?

This course is meant for any person who is dealing with "Personal Data" and includes professionals in IT and non IT companies, legal professionals and students of law in the final year of LLB course or after graduation.

How the Course is conducted:

This is an online course in which a series of lectures will be conducted online like a webinar. Students need to attend the webinar through internet either through computer or through mobile as and when the classes are held.

Reading material would be provided in the form of presentation copies, online articles and other supplementary material.

Naavi is also the founder of www.naavi.org the premier Cyber Law Portal in India and several other associate services including www.ceac.in (Cyber Evidence Archival Center).

More recently, he has pioneered the "Theory of Data" to provide a greater clarity to the concept of Data and Data Protection through three supporting hypotheses namely the "Definition Hypothesis", "Life Cycle Hypothesis" and "Ownership hypothesis".
